

Course Length: The Virginia State Drivers Education consists of two phases. The in-car phase consists of a minimum of seven periods of actual driving and seven periods of observation. Two periods of instructions are given during each session. One period of 50 minutes behind the wheel and one period of 50 minutes observation while the other student is behind the wheel.

All students under 19 years of age, must complete a state approved Driver's education prior to receiving a driver's license. The classroom phase consists of 36 periods of classroom instruction. Students must present proof of classroom completion prior to starting the in-car phase.

If proof is not presented prior to the start of the in-car phase, students are advised to first complete the 36 periods of classroom instructions before enrolling in our in-car phase.

Please note that starting September 01,2010 parents or guardians must participate in an additional 90-minute driver education component as a part of the in-classroom portion of the driver education curriculum as defined by Virginia Code 22.1-205(A).

If the student has missed time during scheduled session days, the student may make up the missed time during other make-up days before joining the regular scheduled class.

Classroom portion is not required for students who obtained a learner's permit at age 19 years and over and
who have held the learner's permit for at least 60 days

• Scheduling in-car: students are responsible for scheduling in-car instructions.

We have found that scheduling your next lesson while in car works best.

Method of payment/price: The price for 7 periods of actual driving and seven periods of Observation is \$250.00 per student made payable to Sara Driving School.

There will be an additional charge of \$120.00 for use of school's vehicle in taking driving test to obtain a driver's license from DMV. This fee does not apply to students under 19 years of age.

Tuition is paid in advance of instructions. There will be a \$35.00 fee for returned checks.



Upon request a refund of any fees or tuition or any part of fees is returned unless the school is capable or willing to perform its part of the Contract within a reasonable time period.

All refunds must be requested in writing. Students will be charged \$35.00 for each lesson performed. Allow two to four weeks for refund.

- Lesson Cancellations: Students must cancel in-car lessons 24 hours in advance or be subject to a \$25.00 fee.
- Sara Driving School does not guarantee that student will pass the state Driver's License examination or
  that the student will secure a driver's license, or that the student will be guaranteed employment upon
  completion of the course.
- It is the responsibility of the student, or in the case of a minor the parent or legal guardian to report to the DMV any concerns regarding school facilities, instructor's behavior or quality of instructions by school.
